GENERAL INFORMATION:

Selective miticide for the control of a variety of mite pests on apples; grapes; fruiting vegetable Crop Group 8-09, cucurbits Crop Group 9; hops; stone fruit Crop Group 12; Crop Subgroup 13-07A: blackberry, loganberry, raspberry, wild raspberry; and tree nuts Crop Group 14, including almonds, beechnuts, , butternuts, chestnuts, chinquapins, filberts (hazelnuts), hickory nuts, pecans and walnuts, for seed production only on grass Crop Group 17 and non-grass Crop Group 18, mint and herbs Crop Subgroup 19A. When used as directed and applied to the foliage, **Acramite 50WS Miticide** provides quick knockdown through contact activity. **Acramite 50WS Miticide** is not systemic in action; therefore, complete coverage of both upper and lower leaf surfaces and of fruit is necessary for effective control.

DIRECTIONS FOR USE:

<u>Field sprayer application</u>: **DO NOT** apply during periods of dead calm. Avoid application of this product when winds are gusty. **DO NOT** apply with spray droplets smaller than the American Society of Agricultural Engineers (ASAE) fine classification. Boom height must be 60 cm or less above the crop or ground.

<u>Airblast Application</u>: **DO NOT** apply during periods of dead calm. Avoid application of this product when winds are gusty. **DO NOT** direct spray above plants to be treated. Turn off outward pointing nozzles at row ends and outer rows. **DO NOT** apply when wind speed is greater than 16 km/h at the application site as measured outside of the treatment area on the upwind side.

DO NOT apply by air.

Buffer zones:

Use of the following spray methods or equipment **DO NOT** require a buffer zone: hand-held or backpack sprayer and spot treatment.

The buffer zones specified in the table below are required between the point of direct application and the closest downwind edge of sensitive freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs, and wetlands), and estuarine/marine habitats.

For tank-mixes, consult the labels of the tank-mix partners and observe the largest (most restrictive) buffer zone of the products involved in the tank-mixture and apply using the coarsest spray (ASAE) category indicated on the labels for those tank-mix partners.

Mixing Instructions:

Always reseal the outer bag in a manner that protects the remaining packets from moisture. Fill the spray-tank with 1/2 the desired amount of water. Then add the required number of water soluble bags of **Acramite 50WS Miticide** with agitation running to disperse the product. Then fill the tank with the remaining amount of required water.

Restrictions:

- Acramite 50WS Miticide is a dry powder sealed within individual water-soluble pouches (WSP). Drop intact WSP directly into spray-tank. The pouches and pesticide will dissolve readily in water.
- 2. Do not allow the WSP to become wet prior to use. Do not handle individual WSP with bare hands or wet gloves as this may cause breakage.
- If broken WSP are found within the overwrap bag, wear chemical-resistant gloves, goggles and a dust mask and dispose of broken WSP according to the DISPOSAL section.
- 4. Always reseal the overwrap bag to protect the remaining unused WSP.

APPLICATION USE RATES AND RECOMMENDATIONS:

To provide maximum control application should be made as soon as mites appear. When used as directed, **Acramite 50WS Miticide** is effective for the control of a variety of mite species, especially two spotted spider mites, European red mites, Pacific spider mites, and McDaniel spider mites. Note: It is not effective against rust mites. **Acramite 50WS Miticide** is primarily active on the motile stage of mites.

RESISTANCE MANAGEMENT RECOMMENDATIONS:

For resistance management, please note that **Acramite 50WS Miticide** contains a Group 20D acaricide. Any mite population may contain individuals naturally resistant to **Acramite 50WS Miticide** and other Group 20D acaricides. The resistant individuals may dominate the mite population if this group of acaricides is used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action but are specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay insecticide resistance:

- Ensure thorough spray coverage to all foliage and fruit.
- Where possible, rotate the use of Acramite 50WS Miticide or other Group 20D acaricides with different groups that control the same pests in a field.
- Acaricide use should be based on an IPM program that includes scouting, record keeping, and considers cultural, biological and other chemical control practices.
- Monitor treated pest populations for resistance development.
- Contact your local extension specialist or certified crop advisors for any additional pesticide resistance-management and/or IPM recommendations for the specific site and pest problems in your area.
